BH2. - CA6. On motion of Supervisor Freeman, seconded by Supervisor Freeman and carried, approves job specification and allocate the position of Deputy Assessment Technician at Range G192 in the Assessor's Office and authorizes the recruitment and filling of said position effective February 1, 2006. Approximate cost in salary and benefits is \$5,844.
