#### Item #4 – School Resource Officer Discussion

The current Tobacco Grant that funds Carolyn's current position expires June of 2023. I am seeking input regarding making decisions moving forward to continue the positive outcomes of that position. Try to replicate or is something different a better fit.

Mike Harper: thinks it is a great position, concern over the last few years is that the duties seem to be blurred. Need to define the position and who has control of it more concretely., so the SRO knows whom is control of what. What are her obligations to the Schools and to the Grant and Probation? Schools are over using.

Trish Alberg: SRO communicating with HRN programs, such as tobacco education, youth advocacy etc. – Very valuable partner in community efforts - the work that has been done has been very beneficial. Very active in community events and such.

Debbie Klein: it is very valuable, she has referred several kids to her agency when needing assistance, part of reason the lines are blurred as far as who is managing that position, most likely has to do with funding. A lot of agencies maybe have tried to take advantage of this position being at the school. Confusion comes from funding not as much as management.

Tim Saxon: Agreed with Judge Harper, have gone outside of the perimeters of this position. SO went for the BSCC grant to hopefully fund the juvenile officer to work with the SRO, and with the SO's staffing issue that has not been met so they have been unable to help with that, Sheriff apologizes for that but are now building their staffing and training up and running again hopefully get their Juvenile Officer. Provide mentoring and reporting to other departments, getting the students help they needed. Good program, but need to lay out better ground rules.
