**A RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF TRINITY SITTING AS THE
TRINITY COUNTY TRANSPORTATION COMMISSION
WHICH AMENDS THE TRINITY COUNTY REGIONAL TRANSPORTATION PLAN**

WHEREAS, the Trinity County Transportation Commission (TCTC) is the Regional Transportation Planning Agency for the Trinity County regions; and

WHEREAS, the Trinity County 2022 Regional Transportation Plan (RTP) was approved by the Trinity County Transportation Commission on February 7, 2023; and

WHEREAS, Page 90 of the 2022 RTP lists Bridge Projects to be completed over the next 10 years; and

WHEREAS, Transportation Projects must be included in the RTP prior to being listed in the Regional Transportation Improvement Program (RTIP) and State Transportation Improvement Program (STIP) and receiving State and Federal funding; and

WHEREAS, the next regular update of the Regional Transportation Plan is scheduled for 2028; and

WHEREAS, the County has determined there is a need to replace Ripple Creek Bridge (No. 05C-0006) which could be programmed into the 2024 STIP; and

WHEREAS, this project is consistent with the goals and policies of the RTP and should be added to the RTP in time for programming of the 2024 STIP.

NOW, THEREFORE, BE IT RESOLVED that the Trinity County Transportation Commission does hereby amend page 90 of the 2022 RTP to include the replacement of Ripple Creek Bridge (No.05C-0006) listed in Exhibit A attached hereto.
