- Chair Lee wants to state that he does not use herbicide in his job, even his supervisor said he does not use in his job
- Chair LeeVice- we did not defy a Supervisor, Chair Chilcote: we are not directed by BoS what to address, we make recommendations to BoS, we want to be equally responsive to anyone who wants to raise an issue

# 7:20 III. On-Going Reports

- a. Restoration Update
- Critically dry water year, restorative flow April 15, peak 4500 cfs, hydrograph posted in Journal next year, post cards have been posted to landowners along the river
- Driest year on record at Shasta Dam
- b. Trinity County Big Game Update, Deer Management Plan Chairman Lee
- Talked with David Cassidy who is the big game Program Supervisor, posted notes on the Google Drive
  - Issue fire danger leads to closure which prohibit access for hunters, last year USFS and SPI closed as well
  - Buck only hunting, Cassidy was supportive, Mentioned count veto authority, Pete Figuero, Supervisor from Redding office, recommendation sot change regulation come from local level, we should make a recommendation to local Supervisor, Chair Lee wants to collaborate with Supervisor on a recommendation
  - Close to releasing new Deep Management Plan, appears to be fairly different from previous versions
  - Appears to be reaching some stability with personnel
- c. Trinity River Update Supervisor Gogan
- Commissioner talked with hatchery manager, they had 500 steelhead return, they do not know why, historically they have 1% return, they release about 450,00, so we are getting 1/10th of 1 percent

d. Department of Fish & Wildlife Report: Andy Hill, Trinity will be fished longer this year, hope to get some wild coho, intent to get wild coho for the broodstock,

- e. Trinity County Collaborative Report Commissioner Dixon, no report
- f. Pacific Fisheries Management Council Commissioner Cole
- emailed copies of McGuire's statement, they will adopt the recommendations in April, will be a bad year, maybe our worst, Do we want to make a recommendation on harvest?
- DeJulio it's a question of opportunity or escapement, Klamath is in over-fishing review, Klamath hasn't met escarpment goals for at least the last 4 years
- Holthaus: heard Klamath projections in line and it was the Sacramento which had taken the biggest hit
- Cole: PFMC cut down projections because of the Sacramento was near collapse,
- last year readjusted size breaks for jacks to 23", those fish turned out to be 4 years and it might have led us to over-harvest jacks
- McGuire is a voting member of the PFMC
- possible if BoS takes an interest in TCFGAC might have \$ to send representative, Gogan might be suitable

- a. Beaver Letter Commissioner Chilcote, started going through agendas and minutes
- b. Steelhead derby update Derby Sub-committee (DeJulio, Holthaus, Chilcote)-Hilthaus contacted Trinity Hatchery and started discussing broodstock, Derrick at the hatchery was very supportive but not his decision they do refer to it in their documents, he referred him to the Hatchery Technical Team, and he reached out to Derrick Rupert ob the Hatchery Team, he was supporting and he will talk to his supervisors and get back Charlie, want to agendize for next Technical Team meeting, we want to get everything in line with departments before approach the fishermen
- c. Brown Trout Policy Statement Letter Commissioner Cole
  - a. wants Kyle to call him so they can discuss the main points, De Julio does not understand why this is necessary and what it will be used for, it would just restate the letter, Gogan put it back on the agenda here, there is a lot of resistance to removing brown trout from the fishermen, keep on the agenda until input from Gogan

## 8:00 V. New Business

- a. Standards of Conduct for Commissioners Chairman Lee and Vice Chairman Chilcote
  - i. Difficult to work under these conditions, communications were muddled in emails, if requested to call if requested, have reached out to County Counsel, had to block emails, drafted Code of Conduct, any input? potentially adopt with input from Counsel or BoS, potentially make retroactive, open to debate and any motions
    - 1. Cole dismayed at unwillingness to discuss big issues, Lee told him he wanted to do small issues, he were not
    - 2. Motion: Cole by present Make edits and typos and chain of command with Supervisors, Second Holthaus
    - 3. 2021 Programs and Goals Chairman Lee
  - ii. Make standing agenda item for November,
  - iii. Some progress with fishing derbies, banquet/auctions might be better fundraisers
  - iv. 3 priority areas: 1) fishing derbies, 2) broodstock program, 3) big game
    - 1. Cole wants to have Gogan present to set priorities
    - 2. Motion: Cole to put off to next meeting when Gogan is present, if he is not present there then, we can move on it, Second by Holthaus
    - 3. Motion Amended: Tabled issue until next meeting and each Commissioner submit top 3 priorities 2 week prior
      - a. Dixon not time sensitive but doesn't want to set precedent that discussion not possible without Supervisor here
      - b. De Julio we don't need to reference Supervisor
- b. Representation at PFMC- Supervisor Gogan, Tabled
- c. Budget- Vice Chairman Chilcote, be prepared to approve at next meeting, think about necessary resources for strategic actions and program priorities

- d. Western Area Power Administration and Trinity Public Utilities District Wildfire Risk Reduction, Reliability, and Asset Protection (WRAP) Project- Chairman Lee
  - i. Draft EIS in August, Scoping Report is published, scoping report would have been a better point to comment, some of the topics in the scoping habitat fragmentation, is kill vegetation but don't remove then increase wildfire danger
  - ii. Lee feels needs more details to understand impact to fish and wildlife
  - iii. Cole, Andy Johnson, PUD is going to BoS next week to ask that Trinity County suspend its herbicide policy
    - 1. Boards agenda isn't posted yet, acting on heresay
    - 2. Holthaus anything can be a herbicide, it's defined by what it does, not by it's name
    - 3. Dixon, there are certain nexuses with fish and wildlife but we need to know more about what is proposed, jumping the gun without knowing what is on the table, state for the record that application of herbicides is a topic that can be of interest to the commission
    - 4. DeJulio doesn't like spending this amount of time on a hypothetical topic,
    - 5. Cole: to mechanically cut will cost 4-5 x more than herbicide, balancing the safety of the wildlife
    - 6. DeJulio would like an evening program by another entity with experience with of fire protection
    - 7. Cole: a motion to have an evening program on this issue, Second by DeJulio:
    - 8. Competing Motion by DeJulio: Take up Evening Program Development at the same time as Priorities, Second by Dixon, passed unanimously
