In 1988 the citizens of Hayfork formed the District (GHVPRD) to manage and maintain Hayfork Park and Pool. The park grounds had been neglected by the County and were in need of repair and upkeep. In 1989, the voters of the District passed Measure A, which assessed \$10 per parcel owner annually. Thirty-five (35) years ago, that amount was sufficient for the District to manage, operate, maintain and improve Hayfork Park and Pool. Now it is not. Annual park District budgets have inched up over the years, mainly due to rising costs of payroll, utilities, pool chemicals and other operations costs. This trend is not sustainable over time.

Measure M will *repeal and replace* Measure A, and the District will maintain the financial ability to manage, maintain, operate and improve Hayfork Park and Pool into the future.
