Our professors and staff do a great job educating local students, but many classrooms and facilities in the Shasta-Tehama-Trinity Joint Community College District are outdated or inadequate to provide students with the facilities they need to succeed.

Our main campus, Shasta College, has classrooms that are over 50 years old.
