### TRINITY COUNTY JUVENILE DETENTION FACILITY

### **PURPOSE:**

Penal code section 919(b) mandates that the Grand Jury will annually inquire into the conditions and management of all public prisons within the county, including juvenile detention facilities.

### **BACKGROUND:**

Construction of the Trinity County Juvenile Detention Facility (JDF) was completed in June 2001. The facility is new, modern, fully staffed and operational. It is operated under the direction of the Trinity County Probation Department and houses up to 24 in-county and out of county juvenile detainees.

The inmate population was 5 on November 4, 2003, the day the Grand Jury Judicial Committee visited the JDF.

### **METHOD OF INVESTIGATION:**

All of the members of the Grand Jury Judicial Committee met with Mr. Terry Lee, Chief Probation Officer, and members of his staff, and toured the Juvenile Detention Facility on November 4, 2003. Prior to the inquiry and during the meeting, the JDF Policy and Procedure Manual and previous inspection reports were made available to the Judicial Committee for review.

Using Board of Corrections procedures for Minors in Title 15 facilities, the members of the Judicial Committee toured every room within the detention facility; discussed routine and significant activities with staff and interviewed 1 male and 1 female post-sentence inmate. Neither inmate indicated any substantial complaint concerning conditions within nor operation of the facility.

## FINDING #1:

Inmate Telephone System - The only significant concern or complaint expressed by anyone, and it was shared by both the staff and inmates, was the reliability and impact of the inmate telephone system. Because the telephone contract has passed through three different companies since being issued, acquiring maintenance or repair for the system has become slow and cumbersome. The impact of the high cost of use routinely results in inmates losing telephonic contact with their families. The system in use in the JDF is under the same contract as the system used in the Trinity County Jail.

# **RECOMMENDATION #1:**

A new Inmate Telephone System contract is currently under preparation, this contract needs to ensure that inmate costs are held to a reasonable level and the revenue from the contract must be separate for the JDF from the Trinity County Jail revenues and be subject to regular audits.

# **FINDING #2:**

The Trinity County Juvenile Detention Facility is the newest, cleanest and best run of this type facility that any member of the Grand Jury Judicial Committee has ever witnessed.

# **RECOMMENDATION #2:**

The management and staff of the JDF should all be commended for the professional and caring accomplishment of their duties.

# **CONCLUSION:**

This facility and those who operate it provide a much needed service and are a credit to our county.
