Item 1. Minutes: Approve meeting minutes from March 14, 2024.

By motion made and second (Ellis/Barrett) to approve (5/0) the minutes of March 14, 2024 as presented.

Item 2: INITIAL COMMERCIAL CANNABIS CULTIVATION VARIANCE REQUEST (CCV-2023-22): An initial commercial cannabis cultivation request of the Planning Commission to reduce the required 350-foot cultivation setback from a neighboring residential structure, pursuant to Trinity County Code Section 17.43.050A(8). The project site is located at 510 Dirt Rd., Hayfork. APN 014-440-044-000. Applicant: Chee Moua.

Public comment was heard from Kachia Moua-applicant representative and Tom Ballanco-Douglas City and being there were no other speakers public comment was closed.

By motion made and second (Barrett/Ellis) to approve by roll call vote 5-0. The Planning Commission moves to:


