<u>Item 2:</u> INITIAL COMMMERCIAL CANNABIS VARIANCE REQUEST (CCV-2023-07) An initial commercial cannabis cultivation request of the Planning Commission to reduce the required 350-feet cultivation setback from a neighboring residential structure, pursuant to Trinity County Code Section 17.43.050A(8). <u>Item 3:</u> INITIAL COMMMERCIAL CANNABIS VARIANCE REQUEST (CCV-2023-20) An initial commercial cannabis cultivation request of the Planning Commission to reduce the required 350-feet cultivation setback from neighboring residential structures, pursuant to Trinity County Code Section 17.43.050A(8). The project site is located at 3191 State Highway 3, Hayfork, CA 96041. APN 016-200-035-000. Applicant: A. Romanova.

By motion made and second (Heaton/Ellis) by roll call vote 4-0 the Planning Commission moves to:

on APN 016-200-042-000 to approximately 315 ft. subject to the conditions set forth in Exhibit A.
