MINUTES

1. <u>CALL TO ORDER</u>

4. <u>REZONE FROM UNCLASSIFIED TO TMBERLAND PRODUCTION ZONE</u>

P-18-08

Public Hearing: Rezone of approximately 296 acres from Unclassified to Timberland Production Zone (TPZ). Located at 4700 FS Rd 37N19Y (3 miles south of Coffee Creek Road just east of Boulder Creek Trail), Coffee Creek. APN: 004-300-02. Applicant: Schroeder.

Deputy Director of Planning Leslie Hubbard presented the staff report. Hubbard advised there is an error in the staff report that states the applicant would like to rezone approximately 320 acres, when in fact, it should be 296 acres to be rezoned. Staff is recommending approval.

Chair Hoard opened the hearing to public comment.

Comments received from Agent for Terry Schroeder Trust, James J. Ostrowski.

No further comments being received, Chair closes public comment period.

Commissioner Matthews moved to recommend to the Board of Supervisors (1) adoption of Negative Declaration, finding that on the basis of the whole record, including the initial study, that there is no substantial evidence that the project will have a significant effect on the environment and that a negative declaration reflects the County's independent judgment and analysis; and (2) approval of the zoning change from Unclassified to Timber Production Zone (TPZ), finding the action to be consistent with the overall goals and policies of the Trinity County General Plan. Seconded by Commissioner Frasier, and carried unanimously.

6. MATTERS FROM STAFF

Deputy Director of Planning Leslie Hubbard advised that on September 13th we will have an Amendment to the Manufacturing Ordinance proposed and possibly one other amendment.
