The Trinity County Superior Court previously received \$200,000 annually and it was reduced to \$25,000.00. Probation is eligible to receive 70% of those funds through an MOU with the court to provide Pretrial Assessments and Monitoring when defendants are released from custody into the Pretrial Program as well as provide data for state funding. Probation submits time studies to draw down funds.  Probation is considering being a provider for CalAIM through Partnership. In short, this decision can provide revenue for activities that probation already does in connecting people to services. The challenge to accessing these funds is billing Medical and providing the supportive data. We are collaborating with county partners in this area. |

Trindel is paying for the training this week. Probation Officers drive all over the county to conduct field visits and searches. We also transport many juveniles between detention facilities and our Superior Court for regular court appearances. Adults and juveniles are transported when arrested and also taken to different resources in the community to reduce their recidivism. We also assist in emergency evacuations and patrol of evacuated areas.
