Press Release to Accompany the Expanded Health Officer Order dated March 30, 2020

Trinity County – Coronavirus (COVID-19) pandemic presents as a real and present threat to Trinity County residents and communities.

In response to the ongoing COVID-19 pandemic threat, on March 30, 2020, the Trinity County Health Officer expanded the original Health Officer Order, dated March 25, 2020. This was to clarify that even though the National Advisory Memorandum on Identification of Essential Critical Infrastructure Workers During the Covid-19 Response considers real estate services and settlement services critical infrastructure employees, **Trinity County does not recognize real estate services and settlement services as essential** in an effort to prevent unintentional spread of the coronavirus.

All other items included in the original Health Order remain in effect.

Anyone choosing to reside in their second home within Trinity County shall self-quarantine for a period of no less than 14 days upon arrival.

All non-residents are being asked to stay out of Trinity County at this time with the exception of essential travel including, but not limited to:

- Emergency responders
- Critical infrastructure employees
- Individuals traveling through Trinity County for medical reasons
- Individuals traveling to and from Trinity County to another county for employment purposes
- Essential thoroughfare traffic including overnight stays
