As a property owner, tenant, or person who has requested notice, please be advised that the County of Trinity County Environmental Health Department (LEA) received a new permit application for a solid waste transfer site permit for the Weaverville Solid Waste Transfer Station Facility. The LEA is certified by the California Department of Resources, Recycling, and Recovery to enforce state laws and regulations at solid waste sites within the county of Trinity.

Description of the Project and LEA's Preliminary Determination

Weaverville Transfer Station is located on the Weaverville Landfill property at 173 Tom Bell RD, Weaverville, approximately 1.3 miles Northeast of the junction of California State Highway 299 and California State Highway 3 North. On 08/06/2024 the LEA accepted for review a permit application package for the existing Weaverville Transfer Station from the County of Trinity. The new permit application submitted cited changes to site were made in the last 5 years. The applicant has proposed to increase to site capacity of facility to peak loading of 45 Tons Per Day (TPD), annual loading of 10,000 Tons and a site capacity of 99.9 TPD.



The Weaverville Transfer Station was built in 1999, as a cost effective option for waste disposal in Trinity County. The LEA finds that the registration permit application for the Weaverville Transfer Station is accurate and complete as required by State statute, and will be submitted to the California Department of Resources, Recycling, and Recovery (CalRecycle) for filing post public notification. The LEA has reviewed and approved the application submitted.
